8. I release Darla's Bed and Biscuit, LLC from any and all liability in which my dog(s) may suffer including but not limited to injury, illness, damage, or death while in the care of Darla's Bed and Biscuit, LLC.
9. I understand that I am financially responsible for the charges my dog(s) will incur during my dog(s) stay at Darla's Bed and Biscuit, LLC and that all charges are due at the time of pick up. I also understand that I am financially responsible for unforeseen charges relating to any damage inflicted by my dog(s) to any property of Darla's Bed and Biscuit, LLC.
10. I understand that I am solely liable for medical care expenses and damages that result from injuries caused by my dog(s) to any person(s) or dog(s). I agree to resolve the matter with the person(s) or owner of the dog(s) in accordance with the law.
